3. Hazards Identification

4. First Aid Measures

5. Fire-Fighting Measures

Extinguishing Media: If product is involved in fire, use CO2 or dry chemical.

Fire And Explosion Hazards: Heating benefin to temperatures above 90°C (194°F) can lead to violent reaction with rapid pressure build-up. If product is involved in fire, noxious, toxic fumes may also be formed.

Effect on birds: low toxicity to birds, acute oral LD50 for Japanese quail is 4237 a.i.mg/kg. Effect on fish: moderate toxicity to fish, acute 96 hour LC50 for Rainbow trout is 4.5 a.i.mg/L.
